EXHIBITOR TERMS AND CONDITIONS

PARTICIPATION:

Upon acceptance of your completed Registration Form, payment and written confirmation from the St. Michaels Food & Wine Festival, the following Terms and Conditions will be in effect.

PAYMENT:

Payment (and written confirmation from the St. Michaels Food & Wine Festival) is required to establish participation. Payment may be made in the form of check or money order. Checks are payable to the St. Michaels Food & Wine Festival and should be mailed to P.O. Box 824, St. Michaels, MD 21663.

THE ST. MICHAELS FOOD & WINE FESTIVAL AGREES TO:

1. Provide the participant with the standard table package as described on the Registration Fact Sheet.
2. The St. Michaels Food & Wine Festival reserves the right to rearrange the floor plan at any time and/or relocate exhibitors should it become necessary in the judgment of the Festival Committee.
3. Security is provided on between 9pm and 9am on Friday and Saturday. Items left in the Festival tents are the responsibility of the exhibitor. The St. Michaels Food & Wine Festival in not responsible for items that are stolen or lost.

THE EXHIBITOR AGREES TO:

1. Promote and display only products that will fit the venue of this event.
2. Accept the location of the assigned space. All space location preferences will be given fair consideration.
3. Not to share the assigned table with unauthorized vendors or personnel.
4. Provide a qualified representative during the show duration.
5. Refrain from dismantling the table before the Festival closes.
6. Arrange for the removal of all materials from the Festival site no later than 6:00pm on Sunday, April 29, 2007.
7. Release the St. Michaels Food & Wine Festival and its Committee of liability for any losses due to participation. This refers to late product shipments, in-transit damage, loss of samples and unauthorized removal of equipment or supplies at the end of the Festival.
8. Complete all questions on the Registration Form and agrees to pay the event fee.
9. Wine distributors agree to provide ample amount of wine for the Festival weekend.
10. Exclusivity is not guaranteed. It is possible, and in some cases probable, that companies offering similar products will participate in this event. Their location may be near or next to one another. St. Michaels Food & Wine Committee will make every effort to place like companies apart, but it cannot be guaranteed.
